IT'S ALL ABOUT EMDG – EXPORT MARKET DEVELOPMENT GRANTS.

Yes. It is that time of year when everyone is now back at work or should be! Time for a client newsletter. The first for 2020.

We are going to keep it short and sharp. No long-winded comment about the bush fires and now floods in some states other than to say how tragic for the loss of lives and those directly impacted by loss of property and business activity.

2019 Applications – the gate will be shut soon. Not the Homework Syndrome but the EMDG one!

As you would already know EMDG works in arrears. You spend your money the government way first and then claim it back, like a tax return in reverse.

For applications for 2019, the last day to lodge is Tuesday March 3rd 2020, but for us to prepare your application we need time to do so.

Some clients are thrill seekers and are yet to send their information in or respond to our request for missing information. You know who you are, so please help us to help you.

It takes me back to my studying days – leaving my studying or assignments to the last possible moment.

As a student there is the "Homework" Syndrome:

For lodgement purposes there is no extension period at all, whatever the reason, the excuse the "dog ate my homework" does not cut the mustard.

2019 Applications - We have already lodged our application but are yet to get paid.

Applications are processed in the order of receipt.

The processing time is dependent solely on Austrade and the allocated staff member. The holidays are over and the processing wheels are slowing starting to turn again. Audit activity and payments are starting to flow.

As soon as we hear from Austrade we will be touch.

We do share a war-story with you about the time taken to be paid. We just got paid a grant for the 2011 year, some 8 and half years after lodgement. We never gave up, we got there in the end. Thankfully the time taken for this one is not the norm.
